NUEVOS REQUISITOS PATRIMONIALES

Se pone en conocimiento de los señores operadores que, a instancias de la Comisión Nacional de Valores, el Directorio de este Mercado, en uso de facultades Estatutarias y Reglamentarias, ha resuelto actualizar los requisitos patrimoniales exigibles a los operadores.

Al respecto, se resolvió establecer en \$ 150.000.- (ciento cincuenta mil pesos) el **Patrimonio Neto Mínimo** que deben acreditar los operadores para registrar operaciones a su nombre en este Mercado.

Asimismo, se han actualizado las escalas patrimoniales clasificatorias del tonelaje hasta el cual se puede operar, las cuales obran en Anexo a continuación.

El nuevo Patrimonio Neto Mínimo así como las nuevas escalas, entrarán en vigencia **a partir del mes de noviembre**.
